2. Closing dates whereby applications must be at the E&T Directorate office:
  - 30 September 2008 for starting Ministry Integrated Learning (MIL) on 1 January 2009
  - 27 March for 2009 starting MIL on 1 July 2009
3. The following recommendation/report forms must be handed by the candidate to:
  - 3.1 The Pastor(s) of local assembly/assemblies where candidate worshipped for the past three years (Appendix A);
  - 3.2 The Secretary of local Governing Body/Bodies where candidate worshipped for the past three years (Appendix B);
  - 3.3 If candidate was employed between completion of studies and application for MIL, referrals from employer(s) (Appendix C);
  - 3.4 Faculty of institution where candidate obtained or are busy doing his/her theological training (Appendix D);
  - 3.5 The secretary of the local Regional committee (Appendix E).

**(NB. A copy of this application form must be attached to each of Appendix A [to the pastor], Appendix B [to the secretary of Governing Body] and Appendix D [to the secretary of Regional committee].**

NB. These forms must reach the E&T Directorate office not later than the dates in point 2 above.
